Chair is going to be working with Dave Schrader on efforts to grow membership. Impromptu anti-war protest was staged. Chair had her vehicle as a parade float in the Pasadena Doo Dah Parade. Chair had fun throwing copies of the US Constitution and candy to the parade watchers. Looking to have LPLAC co-sponsor a film festival to be called Get Free Fest. Preparations for next election cycle are under way too.
